Hence, it is placed in the DLCCC Meeting and issue of Renewal of consent may be considered subject to the following additional conditions.

- 1. This Renewal is issued based on the records furnished by the unit.
- 2. The consent is issued based on the list of products with quantity and effluent/emission

- generation sources with details furnished earlier. For any variation in the above, the unit has to file application seeking fresh consent of the Board.
- 3. The unit shall not use "use and throwaway plastics such as plastic sheets used for food wrapping, spreading on dining table, plastic plates, plastic coated tea cups, plastic tumbler, water pouches and packets plastic straw, plastic carry bag and plastic flags irrespective of thickness within the industry premises. Instead the unit shall encourage use of eco friendly alternatives such as banana leaf, areca nut palm plate, stainless steel, glass, porcelain plate/cups, cloth bag, jute bag etc.
- 4. The unit shall comply with the E-Waste Management Rules 2016. E-Waste as listed in Schedule-1, generated by them shall be channelized through collection centre or dealer of authorized producer or the dismantler or recycler or through designated take back service provider of the producer to authorized dismantler or recycler.
